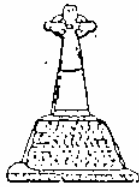

MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON
TUESDAY 14TH OCTOBER 2025 AT BRYMBO SPORTS AND SOCIAL COMPLEX.

Present (Chairman) Cllr P Rogers (also CBC)

The minutes of the meeting held on Tuesday September 9th, 2025, were confirmed as a true record and signed by the Chair.

DECLARATION OF INTEREST-None

2 COUNTY BOROUGH COUNCILLOR'S REPORTS

No report or apology had been received by CBC Gary Brown or CBC Jerry Wellens. CBC Rogers opened by saying that due to the escalation of works on Pentre Vron Road WCBC had sought legal advice and as a result had successfully served an interim injunction the previous day. The owner would be able to put his case forward at a hearing on the 5th of November 2025. CBC Rogers would keep everyone updated and he advised concerned residents who were in attendance to contact planning at WCBC who were very supportive. An anonymous letter had been posted to the Clerk regarding concerns about the unauthorised development relating to Pentre Vron Road. This had been circulated to all members prior to the meeting. CBC Rogers told members that with regards to the new school in Brymbo the Welsh Government had signed off phase 1 and a tender had gone out for the work with a deadline of the end of the week. CBC Rogers said that the bus services in Brymbo had increased from 2 to 3 an hour, and Tanyfron were receiving an hourly service now. Services had increase in Bwlchgwyn. This was good news for all 3 villages, and he urged members to encourage residents to use the services as they would be reviewed each quarter. Works were ongoing on the council properties in Brymbo and Tanyfron. Driveways and fencing were being approved. The road surfacing scheme was now at the halfway point. CBC Rogers said that grit bins had already been filled in anticipation of the bad weather. He urged members to report any that needed filling.

CBC Rogers said that there had been confusion regarding cameras that had appeared on Phoenix Drive however these had been placed by Welsh Government to monitor footfall in anticipation of further schemes.

3. DONATIONS.

Four applications had been received:

Theatre Bara Caws.

Cllr Martin told members that the theatre group had only visited Wrexham once since 2019. The donations fund was to assist with local charities and groups. As a result, members declined to grant funding to the group.

Nightingale House.

A request had been received from the above for a grant of £500.00. Cllr J Williams proposed, and Cllr Hughes seconded that a donation of £250.00 be made. A vote was taken. All were in favour.

Brymbo and District Autumn Show

A request for £250.00 had been made from the above group. Cllr C Williams proposed, and Cllr Ashworth seconded that a donation of £250.00 be made. A vote was taken. All were in favour.

BTRT

A request had been made from BTRT to help with the financial cost of a Christmas event.

Cllr K Peacock proposed, and Cllr C Williams seconded that a donation of £250.00 be made. A vote was taken. All were in favour.

Cllr K Peacock told members that she had informed BVHA to apply for funding towards the Christmas event. Members agreed in principle to grant £250.00 if the correct paperwork was sent to the Clerk.

4. CHRISTMAS EVENTS

The sub-committee had met prior to the meeting to discuss Christmas events. The Chair said that it was going to be difficult this year to hold a CC event therefore it had been decided to support events undertaken by other organisations. As a result, the CC had agreed to donate £250.00 to both BTRT and BVHA if they applied for financial assistance.

Cllr C Williams offered to organise the purchase and delivery of the Christmas trees for Brymbo and TYF schools and one for a location yet to be determined. Cllr K Peacock said that Bwlchgwyn would like to sponsor a tree in aid of Christchurch Church from the Bwlchgwyn environmental fund. All Bwlchgwyn Councillors agreed to do this.

5. QUARTERLY ACCOUNTS AND BANK RECONCILIATION

The Clerk had circulated all income and expenditure to members prior to the meeting, The Chair thanked her for her work. The Clerk and Chair signed the bank reconciliation. Cllr M Peacock proposed, and Cllr Mathew seconded that the accounts be accepted.

6. REPAIRS TO KING GEORGE PLAY AREA BWLCHGWYN.

WCBC had contacted the Clerk to say that the roundabout at the play area needed attention. A quote of £2091.04 ex of VAT had been received. Cllr M Peacock said that the roundabout had been used prior to it breaking and all three Bwlchgwyn councillors would like to see it being fixed. Cllr J Williams proposed, and Cllr M Peacock seconded, that the roundabout be fixed with funds from environmental pot. A vote was taken. All were in favour.

The Chair told members that other play areas in the villages would need to be looked at soon and residents had approached him to set up a support group to try and raise funds for this. He asked members if they were happy to support the group in their work. Members were more than happy to assist.
