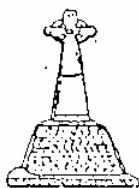

Concerns were raised regarding youths travelling to the Communities and PCSO Jones said this was being dealt with effectively.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

Cllr Kelly said that Highways were dealing with the traffic situation on the A525 by the Moors Inn. Speed monitoring had been agreed after concerns had been raised. The interactive signs for Bwlchgwyn were near completion and Cllr Kelly told members that Darren Green had delivered over and above what had been asked from him.

Cllr Rogers said that the Executive Board had met that day and a loan of £170k had been agreed to the Brymbo Heritage Trust. This would enable them to put in a bid for

the Lottery funding required. Cllr Rogers wished to congratulate the group on what they had achieved so far. Work was due to begin on the new school in Brymbo within the next 18 months as part of the 21st century schools project.

Interactive signs had been erected by the crick during the summer and verge cutting on the link road had been done however Cllr Rogers said this was not up to standard and would be reviewed. Gower Homers had begun work on demoliting the old school in Brymbo.

4. ROADS

Station Road was now two way and being monitored. Issues had been raised re the decision by the Secretary for transport to remove the parapet on Minera Road. CBC Kelly and Cllr Rogers said that it had been left more dangerous than it previously was.

11. SAFETY SURFACE AT KING GEORGE PLAY AREA

The Clerk had received an e-mail from WCBC stating that there was a medium risk to the base of the play area.

The work required needed the removal of the rubber tiles, extending the area out with a sub-base for the extended wet pour and new edging. The quote had been provided for £3847.00. Cllr Kelly said that Mineral CC had completed similar work on their play area and had project managed the complete works at a reduced cost. Members agreed that further information was needed and photographs of the damage needed to be seen before any decision could be made. The Clerk said she would forward these to members before the next meeting.
